Nicole and Melissa from the Duffy Group explained the process that will take place going forward.

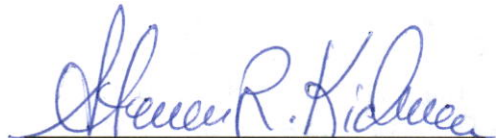

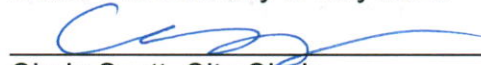
