



**AIRPORT ADVISORY BOARD
REGULAR MEETING MINUTES

- C. Tenant Proposal Review (Capt. Chrissy Genova, Suite 11). There was discussion. Airport Director Lore Davis-McCluskey stated the item was no longer valid and recommended it's removal. A motion was made by Vernon Randel to remove item C from the agenda. The motion was seconded by Justin Feldman and passed unanimously upon a vote.
